### Introduction

The Constitution of the Republic of Poland in Art. 53 declares the right to freedom of conscience and religion, yet in Poland various forms of acts against Christians are noted, caused by their religious affiliation. The presented report shows seventy-two cases of violations of the right to religious freedom in Poland in the period from 1 January to 31 December 2019. They are divided into six categories:

- I. Physical attacks against believers;
- II. Destroying and insulting places of worship;
- III. Destroying and insulting religious symbols and objects of religious worship;
- IV. Restricting public profession of faith;
- V. Discrimination on the basis of religious beliefs;
- VI. Incitement to hatred on the basis of religious differences or insulting a group of the population or a person because of their religious affiliation.

The violations noted in the report are the result of monitoring media reports: systematic review of websites, messengers and social networks in line with the adopted methodology. The first stage of the research was noticing media information about a given act, verifying the event as an act against freedom of religion and confirming the authenticity of the report in several independent sources. Then, data on the perpetrators and the legal consequences imposed on them were collected, if such were available in the media space. The last step was to catalog the act according to the accepted categorization and to create a full record of the event, presented in tabular form, containing the following data:

- 1. Title;
- 2. Date<sup>1</sup>;
- 3. Description of the event;
- 4. Perpetrator (options to choose from):
  - a) a natural person;
  - b) other (e.g. a team of people, a company etc.).
- 5. Perpetrator's age (options to choose from):
  - a) under 18 years of age;
  - b) 18-30;
  - c) 30-45;
  - d) over 45;
  - e) unknown/not applicable.

6. Perpetrator's gender (options to choose from):

- a) man;
- b) woman;
- c) unknown.
- 7. Category of the act (options to choose from):
  - I. Physical attacks against believers;
  - II. Destroying and insulting places of worship;
  - III. Destroying and insulting religious symbols and objects of religious worship;
  - IV. Restricting public profession of faith;
  - V. Discrimination on the basis of religious beliefs;
  - VI. Incitement to hatred on the basis of religious differences or insulting a group
  - of the population or a person because of their religious affiliation.





#### Conclusions


- 1. From January 1 to December 31, 2019, 72 cases of violations of the right to freedom of conscience and religion were recorded among Christians in Poland: 5 physical attacks against believers, 35 acts of destruction and insulting places of worship, 18 cases of destruction and insulting of religious symbols and objects of religious worship, 3 events with the features of limiting public confession of faith, 3 cases of discrimination on the basis of religious beliefs and 8 broadly understood events characterized by incitement to hatred on the basis of religious affiliation.
- 2. The most numerous group of violations of the right to freedom of religion are acts of vandalism against places of worship (sanctuaries, churches, roadside shrines and crosses). The scale of forms of repression in this category is very diverse, including: arson attempts, devastation, partial destruction of property, placing offensive inscriptions or satanic symbols, burglaries and thefts.
- 3. 88,88% of the recorded violations of the right to freedom of religion in Poland in 2019 concern acts against the Catholic faith (64 cases). Christians of other denominations were also victims of repression because of their faith: in 2 cases the Evangelical-Methodist Church and in 1 case the Evangelical-Augsburg Church. In 5 cases, the violations concerned a value common to all Christians, i.e. insulting a cross or a cemetery, or a reaction to the invocation of biblical teaching.
- 4. In 47,3% of the violations, the perpetrators of the incidents were men, women constituted 27,5% of the offenders, while in 25,2%, the gender of the perpetrator was not determined on the basis of police reports and media publications.
- 5. Incidents reported to the Police or the Prosecutor's Office accounted for 69,45% of all repressions. In 30,44%, the violation acts were not reported to the Police or the Prosecutor's Office (5,55%), or no information was provided on the state of the proceedings (25%). These data raise questions about the effectiveness of criminal


proceedings in Poland and the level of victims' awareness of their rights and forms of protection.

6. The analysis of media reports shows that repressions against Christians due to their religious affiliation generate social tensions, entail anxiety in local communities, cause a feeling of threat and unacceptance due to their religious affiliation and the willingness to manifest it.




