

INTRODUCTION

The Constitution of the Republic of Poland declares in Art. 53 the right to freedom of conscience and religion. Despite that, various forms of attacks against believers, places of worship and religious symbols caused by their religious affiliation, are being recorded in Poland.

The presented report reveals 71 cases of violations of the right to religious freedom in Poland between 1 January to 31 December 2024, made public through the media and reported to the Information and Consultation Center of the Laboratory of Religious Freedom¹. They are divided into seven categories:

- 1) Physical attacks on believers (the clergy and laity)** – behaviors directly harmful to the highest good: human life or health, provided that they are accompanied by a religious context (the clergy, service attendees) and anti-religious motives are evident²;
- 2) Destruction and insult of places of worship (churches, chapels, cemeteries)** and
- 3) Destruction and insult of religious symbols and objects of religious worship (crosses, figures, images of saints)** – acts of vandalism are eligible to the first type of behaviour (destruction), the second (insult) concerns destruction with the intention of insulting religious feelings; the type of offence also depends on the will of the perpetrator and the circumstances in which he acted;
- 4) Restrictions in professing faith in public (malicious interference with the performance of religious acts: prayer, liturgy)** – an event preventing the public from pursuing religious freedom: someone does not allow the faithful into the church; raises a false alarm before the service, and so on. Infringements in the form of restrictions on the profession of faith in public may be combined with an act of destruction or insult, nonetheless, these elements do not need to occur;

- 5) Discrimination due to religious beliefs (restrictions of rights because of professed faith)** – situations where people are deprived of their ordinary rights or constrained in them on account of their religious affiliation (in matters of contracts or employment relationships etc.);
- 6) Incitement to hatred on the grounds of religious differences or insult of a population group or some person because of their religious affiliation** – non-physical attacks on believers (individual or on a group of people): hate speech or insult of persons on the basis of their religious affiliation (offensive words, incitement to hatred);
- 7) Other** – cases which do not classify with the other categories of acts.

The violations recorded in the report were collected by monitoring media reports: systematic reviews of websites, instant messengers and social networks in line with the adopted methodology, or have been reported to the ICC via application forms or e-mail messages. The first research stage consisted in adopting information about the given act, verifying the event as an act going against religious freedom and confirming the authenticity of the report in at least two sources³.

Thereafter, complementing data on the perpetrators and the legal consequences imposed on them, provided that such were available in the media space. The final step consisted in cataloging the act according to the adopted categorization and creating a complete metric of the case, presented in tabular form, containing the following data:

³ In the case of media monitoring, these criteria are met provided that: 1) two independent press sources, instant messengers or posts from social networks, are obtained; or by 2) obtaining a single press source, instant messenger or social media post and verifying this source by contacting people or institutions related to the act (including the perpetrator, the injured party, the parish, the office responsible for the care of the cult object - e.g. a monument). The classification of the act notified to the ICC in the report takes place after the verification of the source of information and through contact with people or institutions related to the verified act (including the perpetrator, the injured party, the parish, the office responsible for the care of the cult object - e.g. a monument). Information on the basis of a photo showing the suffered damage is also verified as a confirmed violation, provided that the date of the event is affirmed by at least one media or institutional source (by the curia, parish, religious association, the Town Hall, etc.).



1. Attack on participants in the Way of the Cross in Poznan

Date: 30.03.2024

Description: On 30 March 2024, a recording was made available online showing a verbal attack and aggressive behaviour by a man towards participants of the Way of the Cross for children at risk of abortion in Poznan..

3. Attack by a man with a cleaver during a pro-life demonstration

Date: 20.06.2024

Description: On 20 June 2024 an aggressive man armed with a cleaver attacked a volunteer Pro-Life Foundation and threatened him with death during a street information campaign outside an abortion centre in Olesnica.

4. Attack by a man with a knife during a pro-life demonstration

Description: On 28 June 2024, an aggressive man outside a hospital in Olesnica threatened volunteers Pro-Right to Life Foundation with a knife and destroyed their materials with a sharp instrument.

5. Attack on those praying for an end to abortion

Date: 16.09.2024

Description: According to reports Foundation “Life and Family” on 6 September this year in Poznań a group called “Kolektyw Pyra” actively prevented a rosary prayer in the intention of children at risk of abortion. One of the abortionists lay down on the unfolded poster, wiggled her legs and shouted into the microphone. Others ran around, made noise and demanded that the prayer be stopped.

6. Violent attack on priest

Date: 3.11.2024

Description: On 3 November, a 27-year-old burst into the rectory of St. Brother Albert's parish in Szczytno and brutally beat the priest of the local parish. The perpetrator inflicted several blows with a metal axe on the parish priest's head, which caused, among other things, a fractured skull bone and swelling of the brain tissue. The clergyman also had an extensive wound on his face. The clergyman died in hospital on 9 November.

2. Devastation of the St. John of Nepomuk shrine in Krakow

Date: 01.01.2024

Description: On the night of 31 December 2023 to 1 January 2024, unknown perpetrators committed an act of devastation to the chapel of St. John of Nepomuk on Odmętowa Street in Kraków. The vandals tore the statue of the saint from the chapel and threw it against the ground. The statue was damaged (the fingers of the right hand fell off, which had already been repaired after the April vandal attack). The plaster statue of the Virgin Mary was also destroyed.

5. Theft at St. Stanislaus Church and Wenceslas in Swidnica

6, 7, 8. Devastation (three times) of a Our Lady shrine in Włocławek

Date: 12.02.2024

Description: In Włocławek, the chapel of Our Lady located at the intersection of Rybnicka and Graniczna Streets was vandalised. According to a resident's account, the chapel was destroyed three times over the course of several days in February. The final destruction was carried out on 12 February 2024, when the tiles were broken and the statue was profaned and smashed.

9, 10. Two-time theft in church St. Mary Magdalene in Dobrodzien

Date: 17.02.2024

Description: On 17 February 2024, a forty-four-year-old man committed the theft of an Evangelical and a Bible from St. Mary Magdalene Church in Dobrodzien. Saint Mary Magdalene Church in Dobrodzien. Police investigations established that the perpetrator robbed the church twice, in January and February. During the first theft, the man took a silver-plated lector's cross and an alb from the church.

11. Destruction of the Our Lady shrine in Lubartow

Date: 28.03.2024 (date of media report)

Description: On 28 March 2024, the local media made public information about an act of devastation of a roadside shrine with an image of the Virgin Mary in Lubartow. A notification concerning damage to a statue of the Virgin Mary standing in one of the roadside chapels located in Lubartow was received by the Lubartow police station in February this year. Captured by the police, the forty- three-year-old perpetrator tore the statue of the Virgin Mary from its base and smashed it against the pavement.

2. Amendment of the Regulation on the organisation of religious education

Date: 1.09.2024

Description: As of 1 September 2024, the Ordinance of the Minister of Education of 26 July 2024 amending the Ordinance on the conditions and manner of organising religious instruction in public kindergartens and schools (Journal of Laws of 2024, item 1158) came into force, despite the suspension of the application of the Ordinance issued by the Constitutional Tribunal on 30 August 2024. On 27 November 2024, the Constitutional Tribunal considered the application of the First President of the Supreme Court concerning the teaching of religion in public kindergartens and schools and unanimously ruled that the Ordinance is, in its entirety, incompatible with Article 12(2) of the Act of 7 September 1991 on the educational system in connection with Article 92(1) in connection with Article 25(3) in connection with Article 2 and Article 7 of the Constitution of the Republic of Poland.
